

# Privacy Policy

Venturon Explorer, LLC ("us", "we", or "our") operates <https://venturonexplorer.com> and multiple sub-domains (the "Site"). This page informs you of our policies regarding the collection, use, and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only for rendering services, providing information, and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

## Information Collection and Use

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to, your name, email address, phone number, date of birth, credit card information, passport information, and other information ("Personal Information").

## Use of Personal Information

We may use your Personal Information for various purposes, including:

- Providing and maintaining the Site
- Notifying you about changes to the Site
- Allowing you to participate in interactive features of our Site when you choose to do so.
- Providing customer support
- Gathering analysis or valuable information so that we can improve our Site.
- Monitoring the usage of our Site
- Detecting, preventing, and addressing technical issues
- Providing you with news, special offers, and general information about other goods, services, and events which we offer that are similar to those that you have already purchased or inquired about unless you have opted not to receive such information.

## Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data"). This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

## Cookies

Cookies are files with tiny amounts of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site and other portions may not work as intended.

### **Data Retention**

We will retain your Personal Information until you request us to delete your account. Upon your request, we will delete your account and all associated Personal Information from our systems.

### **Disclosure Of Data**

We never sell your Personal Information. We may disclose your Personal Information to third parties for providing services to customers, including web services and services purchased through us. We may also disclose your Personal Information in the good faith belief that such action is necessary to:

- Comply with a legal obligation.
- Protect and defend the rights or property of [Venturon Explorer]
- Prevent or investigate possible wrongdoing in connection with the Site.
- Protect the personal safety of users of the Site or the public.
- Protect against legal liability.

The CPRA expands upon the rights granted under the CCPA and introduces new requirements for businesses that collect, use, and disclose personal information. As such, we will comply with the CPRA's requirements in addition to those of the CCPA.

### **California Online Privacy Protection Act (CalOPPA)**

CalOPPA requires us to indicate how we respond to "Do Not Track" signals set in your browser. At this time, we do not respond to DNT signals.
